This **Frozen Semen** Sales Contract (the “Agreement”) is entered into as of (Date)

_____ by and between **Tyler Equine LLC**, 2442 Muir Circle Wellington, FL

33414, and the Mare breeder Name: _____ listed below

(“Breeder”).

1. Breeding will be done by using the **frozen semen** supplied by Tyler Equine, LLC.

1. The price of **each dose** of the frozen semen is set forth in Schedule 1 hereto, payment for which shall be fully received by Tyler Equine before the semen dose(s) are released to Mare Owner or the agent of Mare Owner.

2. Tyler Equine LLC. agrees to provide to the Breeder one dose of frozen semen from the Stallion (the “Semen”) for \$650.00 (Six-Hundred and Fifty Dollars) per dose, payable in U.S. Dollars. This breeding agreement allows the Breeder to produce one foal.

3. Before the semen dose(s) are delivered Owner will provide a completed copy of the Mare Information Form, attached hereto as Schedule 2. These documents must accompany this Agreement in order to receive a breeding certificate at the end of the season.

4. Mare owner understands that the mare should be examined by a licensed veterinarian at 45 days and again at 60 days after the last day bred using the frozen semen provided hereunder. Mare owner must then notify Tyler Equine of pregnancy status at that time.

2. **Veterinary Verification Form.** Mare owner must **RETURN** the “Veterinary Verification Form,” attached hereto as Schedule 3 to Tyler Equine in order to receive a breeding certificate.

3. **There is NO live foal guarantee.** There shall be no refund of the Purchase Price. Buyer assumes all risk associated with breeding.

4. **Shipping & Handling:** WellGrove Equine, on behalf of Tyler Equine is responsible for shipping the frozen semen and Mare Owner shall complete the Fax/ Email Request for Semen Shipment, attached hereto as Schedule 4, and return directly to WellGrove via email at support@wellgroveequine.com.
- a) Each frozen semen shipment requires liquid nitrogen to prepare semen container and transfer semen. **Owner shall pay WellGrove liquid nitrogen/handling fee determined by WellGrove, for each shipment to prepare the container** and agrees to add this amount to the fees for the semen.
 - b) A return label will be provided with the semen shipment. Please return the dry shipper within 48 hours. Mare Owners account will be charged costs as determined by WellGrove for each day the shipper is delayed after five days. If the shipper is damaged or not returned within 2 weeks, Mare Owner will be charged a fee determined by WellGrove Equine for the replacement of the dry shipper.
 - c) WellGrove Equine, on behalf of Tyler Equine, shall ship frozen semen from the stallion in viable condition when it leaves WellGrove Equine to the Owner at the shipping destination supplied by the Owner. Tyler Equine and WellGrove hold no responsibility for shipping errors, misrouting, or mistreatment of shipper by shipping company, which might result in damages to frozen semen.
5. **Hold Harmless.** Mare Owner assumes all responsibility for the care, custody, control, and condition of their mare throughout the insemination, breeding, pregnancy, foaling and suckling period, including all veterinary and other additional costs of inseminating, and breeding the mare. Mare Owner further assumes all risk or damage to their mare and to any resulting foal, whether by death, disease, injury, infection or otherwise. Mare owner expressly agrees to waive any claims against, indemnify, release and hold harmless Tyler Equine, its owners, members, managers, officers, directors, representatives, agents, assigns, and employees from any claims, demands, damages, actions, suits, attorney's fees and costs, obligations or liabilities of any kind that are in any way related to the mare or to the breeding or insemination of the mare.

- 6. Liquidated Damages.** Pursuant to F.S. § 672.719, the sole, exclusive remedy of the Mare Owner against Tyler Equine, in case of any default by Tyler Equine under this Agreement, or in case of any damage or injury to the mare, or to the Mare Owner arising out of the default, nonperformance purposeful wrong, or negligence of Tyler Equine, or in the case of any third party claim against Mare Owner arising out of the performance of this Agreement, shall be the amount of payment to Mare Owner by Tyler Equine of the purchase price of the relevant semen dose(s) as specified in Schedule 1 of this Agreement. Mare Owner hereby waives any further entitlement to or claim for any further consequential, actual, punitive damages, for attorney's fees or costs from Tyler Equine, and Mare Owner further waives any claim for equitable relief against Tyler Equine arising in any way out of the purchase, sale, possession or use of the semen purchased under this Agreement.
- 7. Disclaimer of Warranties.** EXCEPT AS TO VIABLE CONDITION OF THE SEMEN WHEN DELIVERED TO THE SHIPPER, TYLER EQUINE EXPRESSLY DISCLAIMS AND EXCLUDES ANY AND ALL EXPRESS WARRANTIES AND ALL IMPLIED WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE AND MERCHANTABILITY, FREEDOM FROM LATENT OR PATENT DEFECTS, AND TYLER EQUINE FURTHER EXPRESSLY DISCLAIMS AND EXCLUDES WITHOUT LIMITATION ALL OTHER EXPRESS AND IMPLIED WARRANTIES. THE SEMEN IS BEING SOLD "AS IS" WITH NO OTHER WARRANTIES, GUARANTEES OR REPRESENTATIONS OF ANY KIND.
- 8. Mare Owner's Representations; Non-Reliance.** Mare Owner represents and acknowledges that prior to the purchase of the frozen semen specified in this Agreement, Mare Owner has enjoyed the adequate opportunity to select and inspect the health records and competition records (if any) of the Stallion; Mare Owner acknowledges that Mare Owner is not relying on anything said or provided by Tyler Equine related to the Stallion, and Mare Owner further states that Mare Owner is solely relying upon Mare Owner's own independent investigation and analysis of the Stallion from which the frozen semen has been collected.

4. Contact Wellgrove Equine **before 4:00 pm the day before shipment is required** to order semen.
5. Once the mare is confirmed in foal at 60-65 days post ovulation, submit Schedule 3 A and Schedule 3 B, Veterinarian/Inseminator Verification Forms, via email to info@segreto66.com or mail to Tyler Equine, LLC 2442 Muir Circle, Wellington, FL 33414. A breeding certificate will not be issued without a completed Veterinarian Verification Form.
